Palmyra Borough Council Meeting Tuesday, January 14, 2025 7:00 PM

President Beth Shearer called the meeting to order at 7:00 PM in Council Chambers of the Palmyra Municipal Center, located at 325 S. Railroad St. Other Council members in attendance included Matthew Andrews, Nancy Fleegle, Jane Quairoli, Marcus Riddell, and James Tesche. Also in attendance were Borough Manager Roger Powl, Assistant Borough Manager Brenda Pera, Western Lebanon County Regional Police Chief Andrew Winters, and Mayor Tom Miller. Anthony Catalani was absent from the meeting.

Public Comment Period #1

There were no public comments.

Consent Calendar

a. Approve the minutes of the December 23, 2024, Borough Council meeting.

Motion: To approve the consent calendar. Motion by Jane Quairoli, second by Marcus Riddell. Motion passed.

Action & Discussion Items

a. Resolution #2025-01 – Appoint Zoning & Codes Enforcement Officers: Ms. Pera informed Council that after Michelle Bowman resigned in September, a new resolution naming William R. Garber, II and Miranda G. Frantz as the Zoning & Codes Enforcement officers was never passed.

Motion: To approve Resolution #2025-01, a resolution to appoint William R. Garber II and Miranda G. Frantz as the Zoning & Codes Enforcement Officers at the discretion of Borough Council, until the First Monday of January 2026. Motion by Marcus Riddell, second by Nancy Fleegle. Motion passed with a 5-1 vote with Jane Quairoli voting against the motion.

b. Action in Equity Proceedings for 317 N College St, 325 N College St, and 227 Pajabon Street (illegal short term rental properties): Ms. Pera explained that the Codes officers have been trying to get a Notice of Violation to the respective property owners of the abovementioned properties regarding the unpermitted use of their property. Since they reside outside of the Commonwealth, there is no easy way to serve them with the required notices of violations. The following motion will permit the Borough to use additional measures to proceed.

Motion:

To authorize the Borough's Zoning Officer, with the assistance of the Borough Solicitor, to prepare and file an action in the Lebanon County Court of Common Pleas against the owner of 317 N. College Street, 325 N. College Street, and 227 Pajabon Street, seeking equitable relief pursuant to Section 380-140.E of the Zoning Ordinance to obtain an injunction against the continued use of the property for purposes not permitted under the Borough's Zoning Ordinance in addition to other remedies available to the Borough. Motion by Marcus Riddell, second by Jane Quairoli. Motion passed.

 - a. New: Mr. Powl mentioned new sinkholes in the detention basin at the 900 block of E. Cherry Street and at the dead end of E. High Street at the Grant Street bridge.

 - a. East Ridge Road Melrose (Phase #1) Off-Site Stormwater Update: Council agreed to discuss the following options at the January meeting.
 - Borough troubleshoots and repairs existing drain tile on northside of E. Ridge Rd and requires developer to pay Park & Rec Fee-In-Lieu of money to Borough instead of using for stormwater improvement.

- Developer removes the existing drain tile pipe along the north side of E. Ridge Rd within our existing easement area and install the new drainage/infiltration trench system and allow the water to discharge and flow east along the north side of the road. Borough would pay the approximate \$25,000 difference in cost between Park & Rec Fee-In-Lieu money and cost of project.
- Property owners reconsider granting the necessary stormwater easements on their
 properties to enable Developer to use Park & Rec Fee-In-Lieu money to extend
 existing discharge pipe underground to the south to an east/west alley right of way
 to a temporary dead-end inlet on the east side of N. Lincoln St.

Councilor Fleegle commented that she visited the site with some of the affected property owners and determined that the second option is the most serious option in providing the best resolution.

After considering all the options, Council developed the same consensus.

Motion:

To approve the option in which the Developer removes the existing drain tile pipe along the north side of E. Ridge Rd within the existing easement area and install the new drainage/infiltration trench system designed by Rettew and allow the water to discharge and flow east along the north side of the road. Borough will pay the approximate \$25,000 difference in cost between Park & Rec Fee-In-Lieu money and cost of project and expense the funds from the Capitol Reserve Fund. Motion by Nancy Fleegle, second by Jane Quairoli. Motion passed.

- b. Street & Alley Maintenance: Mr. Powl commented that the Public Works Superintendent would like to eradicate many of the alley potholes by digging the potholed areas out and reestablishing the alley base then, overtopping with rolled millings.

Solicitor's Report: Mr. Powl reported that he spent the previous week at the Lebanon County Courthouse in a jury trial for the Medina vs. The Borough of Palmyra lawsuit regarding stormwater in the 300 block of East Cherry Street. The Borough prevailed in the verdict and the plaintiff was awarded no monetary damages.

- i. Borough Manager's Report: Mr. Powl reported that one of the Public Works crew members submitted his two-week resignation.
